### **RELEASE AND WAIVER OF LIABILITY, AND AGREEMENT TO PARTICIPATE**

- 1) ACKNOWLEDGE, agree and represent that I understand that:
  - a) I am qualified, in good health and in proper physical condition to participate in the Activity. I further agree that if at any time I believe the conditions to be unsafe, I will immediately discontinue further participation in the Activity;
  - b) The Hay River Shooting Club (HRSC) and/or the sponsor of the Activity (the "Sponsor"), if any, may use my name and likeness for any and all promotional purposes without further compensation or permission;
  - c) the decisions of the Hay River Shooting Club (HRSC) and the Sponsor are final with respect to all aspects of the Activity, including but not limited to, eligibility of participants, rules of the Activity, and the awarding of prize(s), if any.
